About - Westbank First Nation

Located in south-central British Columbia, Canada, Westbank First Nation is one of eight Okanagan Nation communities. The Syilx traditional territories extend from the south-central interior of B.C. to north-central Washington State. The Syilx people are a division of the Interior Salish, speak the Nsyilxcən language, and have inhabited the valley for thousands of years.

Westbank First Nation is comprised of five reserves totaling approximately 5,340 acres. Tsinstikeptum Reserves 9 and 10 borders Okanagan Lake and are in close proximity to the City of Kelowna, one of the fastest-growing cities in British Columbia. Kelowna has been rated among the most competitive places to do business in the Pacific Region of North America and is also one of the most livable cities in Canada.

Westbank First Nation has implemented one of the most comprehensive sets of community laws in Canada that cover the development and regulation of reserve lands. All persons residing or conducting business on reserve are subject to Westbank First Nation Laws.

Approximately 40% of WFN lands are developed and are fully serviced with cable, water, sewer and other utilities. The remaining lands are very desirable for future economic growth as the area responds to increasing demands for development.

Through its administration, Westbank First Nation operates a number of community services, including daycare and preschool services at Westbank Child Development Centre, and Sensisyusten House of Learning, a kindergarten to grade 6 elementary school.

There are approximately 900 Westbank First Nation Members, the majority of whom reside on reserve, along with 11,300+ non-member residents.

To support the needs of the expanding population base, there are a number of malls that offer a wide range of retail and commercial services. Anchor tenants include Winners, Walmart, Superstore, Xtreme Landmark 8 Cinema, Home Depot, Canadian Tire and several major fastfood outlets.

In response to the needs of business, the Bank of Montreal, Royal Bank of Canada, Toronto Dominion Bank, CIBC, Peace Hills Trust, and the First Nations Finance Authority provide a broad spectrum of financial conveniences for the WFN community.

The Okanagan Valley is world-renowned as a major travel destination. Mild climates combined with stunning scenery and world-class skiing, golf and wine attractions create an abundance of activities for visitors. The Westbank First Nation administration recognizes the importance of tourism as being a significant part of the reserve economy and promotes tourism ventures on the reserve.

On April 1, 2005, and after two decades of community consultation and negotiation, the WFN Self-Government Act came into effect. The objective of the Chief and Council is to continue to grow the WFN economy and provide a solid and predictable economic climate in which businesses can flourish and members can prosper.

Governance Structure & Commitment

The NDC parent board is responsible for developing and maintaining effective board governance structures, systems, and reporting processes for the subsidiary group of companies. As part of its ongoing responsibility, the Board will review its charter and terms of reference at least every five years to ensure best governance practices and policies. Also, annual Chair and Director self-evaluations and assessments of Board competencies will serve to identify any knowledge gaps. This will facilitate and encourage new potential Directors to join to ensure orderly succession and renewal of the Board as required.

Board meetings for the four operating companies are held quarterly for one half day up to one full day and are held at the NDC Corporate offices on the Westbank First Nation. There will also be committee meetings, including Financial Statements Approval, Planning & Audit (July), Finance & Investment (3-4 times per year), Strategic Planning (once/year), Executive Human Resources/CEO (2-3 times per year), and a Board evaluation meeting in the last quarter each year. Finally, special meetings may be held at the call of the Chair.

The NDC Chair and Directors will be required to attend a minimum of eight (8) meetings each year including the four quarterly operating company meetings, the Finance/Audit approval, the AGM, the Strategic Plan review, and Board Evaluation meetings each year. For this, the Chair will receive an annual retainer of \$20,000 and each Director, \$10,000. Additional honorariums of \$350 for half-day and \$600 for full-day meetings will be paid for other committee, subsidiary and special meetings as required. Costs related to travel to attend Board meetings will be reimbursed.



Board Director Profile

Currently, NDC is seeking a Chair and Board of Directors who are preferably members of Westbank First Nation; residents British Columbia (and preferably located in the Okanagan); and who can commit to a three (3) or four (4) year term with the possibility of renewal.

As a group, appointees will bring various capacities to the Board table. Key areas of expertise and experience will be in real estate, community building, economic development, investment management, natural resources/forestry, executive leadership, and transactional/legal knowledge. Appointees will be known for their integrity and ethics and possess sound and independent judgment, insight, business acumen, and a collaborative approach.

The NDC, in recent years, has experienced significant growth with a greater focus on real estate development to further diversify its existing portfolio of business. The ideal individual(s) will bring a strategic growth lens as a director and also bring the following experience and competencies to the Board at NDC:

- A national, regional and local perspective and knowledge of the dynamics of Indigenous communities and leaders, combined with an understanding of the diverse traditions and protocols within First Nations communities
- Knowledge of Westbank First Nation history, lands and culture
- Ability to read and evaluate financial statements and business plans
- Demonstrated previous board or committee experience combined with strong knowledge and understanding of best practices in governance
- Ability to attend all Board meetings and relevant Committee meetings, including travel and the necessary time commitments
